Using buyer agency agreement for buying multiple properties of different types

QUESTION: I want to work as a buyer agent with an investor who is interested in purchasing multiple properties, both residential and commercial. Will the Exclusive Buyer Agency Agreement (form 201) work for this purpose?

LEGISLATIVE & REGULATORY UPDATE

The second year of the biennium, which is the legislative short session, will convene on Wednesday, April 24, 2024 at 12:00 PM. With this being the second year of the legislative session, only certain bills may be considered by the General Assembly. Bills for consideration include legislation related to the State budget and bills that passed out of the chamber where they were introduced in 2023, to name a few.

As a reminder <u>Senate Bill 677</u> – Surveyors of Right of Entry/Exped. Comm. Bldg. passed both Chambers and was enacted into law on October 21, 2023. The bill provisions are as follows:

- Requires a local government to perform plan review and issue building permit decisions for commercial and multifamily building projects that are sealed for construction by an applicable engineer or architect within 45 days. If there are changes that require a new submission, the local government has 10 days to review.
- Creates the option for the permittee to do a pre-submittal meeting prior to permit application for eligible permit applicants to determine whether the permit applicant possesses necessary plans and sufficient information the local government would require for building permit plan review.
- Provides alternative methods using third-party reviewers if the local government is unable to complete plan review within the applicable timeframes.

Effective July 1, 2024, and would apply to permit applications submitted on or after that date.
