LEGISLATIVE UPDATE

Housing is one of NCR's top priorities. Therefore, passing legislation that creates more housing at all price points will be impactful legislation for REALTORS® working in both commercial and residential sectors, as well as consumers across the state. House Bill 765 will further expand access to housing, strengthen our communities, boost local economies, and create a brighter future for all North Carolinians. It offers meaningful reforms that will reduce unnecessary regulatory barriers imposed by local governments—barriers that drive up the cost of housing and delay much-needed development.

House Bill 765 does not create new zoning laws but reiterates that local government officials must adhere to laws already passed by the NC General Assembly and those codified in case law.

While this legislation was originally subject to the crossover deadline, it now has a budget component and can still advance in the House. An increased fee for coverage under a

construction or industrial NPDES general permit from \$120 to \$125 was included to allow for future DEQ changes.

NCR will be implementing a media campaign to support housing efforts.

Contributions to RPAC are not deductible for federal or state income tax purposes. Contributions are voluntary and are used for political purposes. Suggested amounts are merely guidelines and you may contribute more or less than the suggested amounts. The National Association of REALTORS® and its state and local associations will not favor or disadvantage any member because of the amount contributed or a decision not to contribute. Your contribution is split between National RPAC and the State PAC in your state. NC RPAC supports the efforts of National RPAC and contributes a portion of its contributions to National RPAC. Contact your State Association or PAC for information about the percentages of your contribution provided to National RPAC and to the State PAC. The National RPAC portion is used to support federal candidates and is charged against your limits under 52 U.S.C. 30116. In-kind contributions/donations are not included for the purposes of the National RPAC State PAC split. NC law requires political committees to report the name, mailing address, job title or profession and name of employer or employee's specific field for each individual whose contributions aggregate is in excess of \$50 in an election cycle. North Carolina law prohibits contributions of cash in excess of \$50 per day. Federal law prohibits contributions of cash in excess of \$100 per year. Contributions can only be accepted from individuals; in the form of personal checks, credit/debit cards and cash less than \$50 per day/\$100 per year. contributions from corporations or business entities cannot be accepted.
